EXPANDED PREGNANCY AND POSTPARTUM COVERAGE FOR SOONERCARE MEMBERS



# The Oklahoma Health Care Authority has expanded coverage for most SoonerCare members receiving pregnancy and postpartum services

- New Coverage and Care Levels
- Income threshold up to 205% of federal poverty level
  - \$38,460 for a household of two
  - a single pregnant woman is considered a household of two
- 12 months of continuous postpartum coverage



### **Full SoonerCare Benefits**

- Postpartum care and care coordination
- Lactation consultation services
- Prescription drugs
- Genetic testing
- Vision and hearing services to treat disease
- Physical therapy
- Occupational therapy



### **Full SoonerCare Benefits (continued)**

- Speech therapy
- Preventive primary care
- Increased dental benefits during and after pregnancy
- Tobacco cessation and counseling
- Behavioral health care
- Substance use disorder treatment



### **Doula Services - Stakeholder engagement**

- Stakeholder Engagement:
  - External stakeholder meetings began in March 2022.
  - Workgroup members consisted of practicing doulas and community members interested in maternal & infant health outcomes.
  - Involved stakeholders weighed in on the program design and reimbursement



### **Proposed Oklahoma Doula Services Model -**Coverage

- Proposed Implementation Date: May 2023 or after
- Prenatal & Postpartum Visits Up to eight (8) visits
- · Labor & Delivery One (1) visit
- · Visit Requirements

  - 60 minutes minimum visit length
     Must be face-to-face
     Prenatal and postpartum visits may be conducted via telehealth
     Labor and delivery services may not be conducted via telehealth



### **Proposed Oklahoma Doula Services Model -**Coverage (cont.)

- The service must be recommended by a physician or other licensed practitioner of the healing arts within their scope of practice under State law.
- The following providers may make a recommendation for doula services:
  - Obstetricians
  - Certified Nurse Midwives and
  - Primary Care Providers
    - Physician
    - Physician Assistant
    - Certified Nurse Practitioners



### **Proposed Oklahoma Doula Services Model -**Coverage (cont.)

- OHCA will create a form/template that may be used to meet documentation requirement for the referral.
- No Prior Authorization (PA) will be required to access the standard benefit of eight (8) prenatal / postpartum visits and one (1) labor and delivery visit.
- A PA may be submitted to request additional visits beyond the eight (8) prenatal / postpartum visits for members with extenuating medical circumstances.



### Proposed Oklahoma Doula Services Model -**Visit Location**

- Doulas coordinate directly with the member and their family to determine the most appropriate service location for prenatal and postpartum visits. Service locations may include:
  - Member's place of residence;
  - · Doula's office;
  - · Physician's office;
  - · Hospital: or
  - · In the community.
    - · There is no coverage for home births



### **Proposed Oklahoma Doula Services Model -Exclusions**

The following are excluded from reimbursement:

- · Travel time & mileage:
- · Transportation provided to the member, infant, and/or family (SoonerRide available);
- Room & board;
- · Phone calls, text messages, and emails;
- · Payment for certification and/or recertification expenses;
- · Administrative overhead
- No-calls / no-shows:
- · Group services;
- Services that are not medically necessary;
- Multiple births (twins, triplets, etc.) are not eligible for additional reimbursement
- There is no separate reimbursement for false labor
  - Payment for false labor is included in the labor and delivery fee



## **Proposed Doula Model - Provider Requirements**

- Must be 18 years of age;
- Required to obtain an NPI;
- Required to use taxonomy 374J00000X;
- ACA screening fee will not be required for individual doulas;
- Provider type: 57 Other Service Provider;
- A provider specialty will be assigned in the system.

### **Proposed Doula Model - Reimbursement**

- Reimbursement will be based on a percentage of the current physician schedule
- Prenatal / Postpartum Visits
  - Flat rate per visit
- Labor & Delivery Visits
  - Rate for vaginal delivery
  - Rate for caesarean deliveryRate for a vaginal delivery after previous caesarean
  - Rate for a caesarean delivery following a vaginal delivery attempt after previous caesarean delivery

### **NEW Donor Milk for Babies in a Home Setting**

### REIMBURSEMENT:

- In the inpatient setting, it will be reimbursed within the prospective Diagnosis Related Group (DRG) payment methodology for hospitals
- In an outpatient setting as a medical supply benefit, it will be reimbursed as a durable medical equipment, supplies, and appliances (DME) item
- Does <u>not</u> require a Certificate of Medical Necessity

### **NEW Donor Milk for Babies in a Home Setting**

### RULES:

- Must be obtained from a milk bank accredited by, and in good standing with, the HMBANA
- Milk bank must be contracted with the Oklahoma Health Care Authority (OHCA) as a Durable Medical Equipment (DME) provider.
- Coverage shall be extended for as long as medically necessary, but not to exceed an infant's twelve (12) months of age  $\,$
- A new prior authorization will be required every ninety (90) days

### **NEW Donor Milk for Babies in a Home Setting**

### Medical Necessity Criteria:

- Other feeding options have been exhausted or are contraindicated
- Baby's biological mother's milk is contraindicated, unavailable due to medical or psychosocial condition, or mother's milk is available but is insufficient in quantity or quality

### **NEW Donor Milk for Babies in a Home Setting**

### Medical Necessity Criteria

The infant has one (1) or more of the following conditions:

- Born at Very Low Birth Weight (VLBW) (less than 1,500 grams)
- Gastrointestinal anomaly, metabolic/digestive disorder, or recovery from intestinal surgery where digestive needs require additional support
- Diagnosed failure to thrive
- Formula intolerance with either documented feeding difficulty or weight loss
- Infant hypoglycemia
- Congenital heart disease
- Pre or post organ transplant
- Other serious health conditions where the use of donor human breast milk has been deemed medically necessary and will support the treatment and recovery of the infant as reflected in the medical records or by a physician (MD or DO), physician's assistant, or advanced practice nurse
